## **NOTIFICATION FOR 3<sup>rd</sup> PHASE MANUAL (OFFLINE) COUNSELLING OF 'M' & 'E' GROUP TO FILL-UP REMAINING VACANT SEATS OF GOVT./PPP ITIs FOR 2018.**

This is for information of all concerned that 3<sup>rd</sup> phase offline manual counselling for both M and E Group will be conducted as per schedule given below to fill up remaining vacant seats and **some newly affiliated trades of Govt./PPP ITIs**. DGT, Govt. of India has accorded affiliation of different trade units on 17.09.2018 for the session August-2018.

**Numbers of vacant seats are limited. Live vacancies of M and E group trades are available in the website.**

Merit listed valid candidates of M and E Group, who could not participate in the online counselling OR did not get any seats in online counselling OR could not take admission even after allotment of a seat due to different reason and having following ranks are only eligible for this Offline Counselling.

Candidates who are debarred from admission for **erroneous percentage of marks** are also eligible to participate in this offline counselling. Such candidates will report with their erroneous rank card as per given schedule in Annexure-A. However, their **new rank** will be given on the basis of actual percentage of marks obtained in Madhyamik or equivalent examination.

**Candidates, who have already taken admission in any Govt./PPP ITIs through online or offline counselling or take allotment through 1<sup>st</sup> and 2<sup>nd</sup> phase of offline counselling, are not eligible to participate in this Offline Counselling (3<sup>rd</sup> Phase).**

Seats will be allotted completely on the basis of 'M' Group rank list or 'E' Group rank list. Willing eligible candidates must report physically at the venue of the counselling on the specified date and time and should bring with them Valid Rank card along with all testimonials (including SC/ST/PH certificates) in original.

Failure to report at the scheduled date and time will make the candidate ineligible for counselling.

**Please note that calling for counselling does not ensure allotment of seats. Allotment of a seat to a valid and eligible rank holder depends on his/her rank and availability of vacant seat at time of his/her turns. Manual counselling will continue till there will be availability of seats and the counselling will be stopped when all eligible vacant seats will be filled up.**

**Once a seat is allotted to a candidate through manual counselling, the allotted seat cannot be changed or cancelled.**

All candidates and guardians, who will be present in the counselling venue, are cordially requested to maintain discipline at the counselling venue for smooth conduction of the counselling process.
