Sub: Guidelines for admission to remaining vacant seats of 2nd Year Diploma Courses for the session 2020-21 and the carried forward vacant seats from the last session (2019-20) to the 2nd year of Diploma Courses directly by the respective Self-financed Polytechnics

Whereas, the West Bengal State Council of Technical & Vocational Education & Skill Development (WBSCTVESD) has already published the necessary guidelines for admission to the 2nd year of Diploma Courses in State Polytechnics for the academic session 2020-21 in accordance with the notification issued by the Department of Technical Education Training & Skill Development vide no. TETSD-14099/26/2020-ESTT SEC-Dept. of TET&SD, I/101550/2020, dated 1st October, 2020.

<u>AND</u>

Whereas, in accordance with the said guidelines, WBSCT&VE&SD conducted online counseling in three phases for admission of candidates to all polytechnics including self-financed polytechnics under its affiliation. After completion of counselling, it has been observed that a good number of seats in the 2nd year of diploma courses are lying vacant.

<u>AND</u>

Whereas, it has also been observed that a good number of seats in the 2nd year of the diploma courses are also lying vacant due to carried forward vacancies from the first year of the last session i.e. 2019-20.

Now, Approval Process Handbook of the AICTE states that in addition to 10% of sanctioned intakes under "Lateral Entry Scheme" on supernumerary basis vacant seats (S) shall also be available to the Institutes where;

S = SI - (SI - C - F + B)

Where, SI = Sanctioned Intake

- C = Number of cancellation and Less Registration in the first year
- F = Number of students not eligible for admission to 2^{nd} year
- B = Number of students of previous batches eligible for re-admission in the 2^{nd} year

In view of the above and in pursuance of the order issued by the Technical Education Training & Skill Development under Memo No. 992-TET(Poly)/14A-01/2019 dated 9th August, 2019, the WBSCT&VE&SD hereby accords permission in the matter of admission to the carried forward vacant seats from the first year

of last session of diploma courses in Engineering & and Technology of the self-financed polytechnic with the following terms and conditions:

- 1. Candidates passed HS (Vocational) from WBSCT&VE&SD **OR** passed 10th + 2 years ITI **AND** have valid rank in the Provisional Merit List published by the WBSCT&VE&SD, are eligible for admission in the 2nd year of Diploma Courses.
- 2. WBSCT&VE&SD will provide a panel in the council's website <u>www.webscte.co.in</u> under the caption "Application for Decentralized Admission in Self-Financed Polytechnics", wherein the aspiring candidates will provide their details and the name of the Self-financed Institution in which admission is sought and also upload the scanned copies of the eligibility documents. The WBSCT&VE&SD will prepare Institution-wise Merit List based on the applications received through the portal and will send the same to the respective institution for taking admission against vacant seats.
- 3. Application for admission of students against the vacant seats has to be obtained by giving open advertisement in newspapers or in the official website of the institution or through other modes.
- 4. The seats, if any remaining vacant after giving preference to the candidates mentioned under serial no. 1 above, may be filled up from amongst the **Institution-wise Merit Listed candidates** who have passed HS (Vocational) from WBSCT&VE&SD **OR** passed 10th + 2 years ITI.
- 5. Total number of students in the 2nd year must not cross the limit specified by the AICTE
- 6. Admission through lateral entry is not applicable for second shift.
- 7. Candidates who have already taken admission in any Government Polytechnic through counselling are not eligible to take admission in the vacant seats of self-financed polytechnics.
- 8. Fee structure will remain same as was in previous year.

This order is issued with the approval of the competent authority and valid for the academic session 2020-21 only.
