All valid rank holders are requested to take note of the following information related to online counseling.

- 1. Website for online counseling is <u>www.webscte.co.in</u>
- 2. Online counseling (Registration & Choice filling) will start on and from **09.11.2021**. Guideline and information related to the counseling process will be available in the counseling website shortly.
- 3. Valid rank holders are advised to keep in touch with the website for **notifications** to be uploaded by the Council time to time.
- 4. Candidates will be able to participate in the online counseling process from any place where **computer with internet connectivity** is available.
- 5. **Provision of Deactivation / Correction:** In case, a candidate has wrongfully declared himself/herself as SC, ST or PC at the time of filling up the application form, he/she will be provided with **one time** chance to deactivate the same at the time of registration for online counseling process. **But, activation of any reservation category will not be allowed in the counseling process**.

- 6. At the time of choice filling, candidates have to fill all available choices according to their preferences. [**Example**: If, Jnan Chandra Ghosh Polytechnic is the most preferred institute for a candidate, he/she has to put Jnan Chandra Ghosh Polytechnic at No. 1. Then he/she has to put his/her 2nd preferred institute at No. 2 and so on.]
- 7. Prior to proceed for registration, candidates have to verity his/her every personal detail on the screen carefully to avoid erroneous allotment.
- 8. Candidates who will opt for **Auto-up-gradation** shall have to book their allotted seats provisionally. For booking of the provisionally allotted seat, a candidate has to pay Rs.1,000/- through online mode and has to wait for the result of the next phase.
- 9. Candidates who will desire to take admission to their allotted seats in any phase of seat allotments under the online counseling process, have to opt for **final allotment** and take print out of the **Final Allotment Letter cum Money Receipt** after making payment of Rs.500/-towards **Seat Booking Fee** through online mode. Then, they have to send all documents through mail **within the last date of admission** as specified in their allotment letter.
- 10. All candidates are advised to enter, save and lock their given choices and retain a copy of their final list of choices for future reference. They should also keep their **Passwords** safe and protected.
