NOTIFICATION

Sub: Transfer of students of Elite Polytechnic Institute, Mogra to the listed Self-financed Institutions of this Council.

Whereas the Elite Polytechnic Institute, Mogra did not apply for renewal of affiliation to the Council and whereas the institute did not submit any approval letter from AICTE to Council for the session 2021-22, this Council is mandated to oversee the academic functioning of such institutions in conformity with the guidelines of the regulatory bodies of Central government and with consultation with State Government." Section XII states that the Council will "regulate all institutions under its umbrella so far as their academic and examination aspects are concerned".

Now, as approved by the Recognition Committee and as per terms of WBSTVESD Rules 2019 Rule 9(2) (C.P.- 102)The Council is satisfied that there is cogent reason for transfer of student from EPI polytechnic to any other self-financed polytechnic as the Institute has failed in continuing the academic activities as per Guidelines and Regulations of the Regulatory Bodies of the Center and also of WBSCTVESD.

A. The conditions to be followed for transfer of the students of Elite Polytechnic Institute, Mogra to other Self-financed institute:

- 1. Student will have the option to choose the Institute of their own choice.
- 2. Transfer of students will be affected on first come first serve basis.
- Institute to verify the student details based on the registration number, identity card of EPI, Mogra and last semester marksheet.
- 4. Details of the students accepted by each institute to be submitted to the Council within the schedule as mentioned below.
- 5. Management Quota will not applicable in case of transfer of students.

B. Schedule:

- 1. For the existing 5th Semester students

 - Transfer process to be completed within 10th January, 2022 to 15th January, 2022 Institute to send the details to the Council by 19th January, 2022. -
- 2. For existing 2nd Semester students

 - Transfer process to be completed within 27th January, 2022 to 3rd February, 2022 Institute to send the details to the Council by 9th February, 2022.
- 3. Council will provide the list of the students with their contact details; effort is to be taken to ensure that all students in the list are transferred to the institutes against the listed
- 4. List of the Self-financed institutions with their existing vacancies, who have submitted their No objection to Council is provided in Annexure I
- 5. Institutions to send the final details to Email: <u>registrar@wbscte.ac.in</u> & Format provided in Annexure II

Please note that the Council does not recommend any student to any institution. Any one claiming the same may be ignored.
