NOTIFICATION FOR 2ND PHASE OFFLINE COUNSELING **OF MERIT LISTED CANDIDATES OF PET-2022** **(ACADEMIC SESSION 2022-23)**

(FOR ADMISSION OF STUDENTS TO **SELF-FINANCED INSTITUTIONS** OFFERING DIPLOMA COURSE IN PHARMACY)

To fill-up the remaining vacant seats in the existing Institutions and also for the newly affiliated Institutions, it has been decided that the 2nd Phase Offline Counselling will be conducted with the eligible and merit listed candidates of **PET-2022** as per the following schedule.

There is NO VACANCY in Government Institutions.

Candidates who could not participate OR could not be allotted any seat OR could not take admission even after being allotted a seat in the 1st Phase of Offline Counseling due to various reasons, are eligible to take part in the 2nd Phase Offline Counselling. **Candidates, who have already taken admission in any institute through 1st Phase Counseling of PET-2022, are not eligible for this 2nd Phase of Counseling.** Seats will be allotted completely on the basis of ranks in PET-2022.

Willing eligible candidates must report **physically** at the counseling venue on the specified date and time and should bring with them the **Admit Card** of **PET-2022** along with admit cards, marksheets, certificates of Madhyamik and Higher Secondary or Equivalent Examinations along with Aadhaar Card or Voter Identity Card in **ORIGINAL**. All candidates should also bring a set of self-attested photocopies of all these documents. However, medical fitness certificate, domicile certificate and filled in anti-ragging affidavit have to be submitted at the time of admission to the allotted polytechnic.


Candidates will have to pay an amount of Rs. 500/- (Rupees five hundred) only in CASH towards Seat Booking Fee at the counseling venue, if he/she is allotted a seat during Offline Counseling.

Please note that calling for counseling does not ensure allotment of seats. Allotment of a seat to a valid and eligible merit listed candidates depends on his/her rank and availability of seats at the time of his/her turn. Offline Counseling will continue till there will be availability of seat(s) and will be stopped immediately when all seats will be allotted. The counselling may continue till late evening and the council is not responsible for arrangement of transport, food and accommodation for the candidates and/or their guardian during the entire process of counselling.

Once a seat is allotted to a candidate, the allotted seat cannot be changed or cancelled.

All candidates and guardians, who will be present in the counselling program, are cordially requested to maintain discipline for smooth conduct of the counselling process.
