- 1. Final list for admission of the candidates through 1st SPOT COUNSELING will be available for each institution as per the existing merit list of JEXPO/VOCLET 2022 extrance examinations.
- 2. All the candidates are to report by **1:00 pm at the Institution applied/selected** by the candidate through online portal for 1st SPOT COUNSELING on **19th October**, **2022**.
- 3. The candidates will stand in queue and a numbered slip according to their arrival be handed over to them. Attendance register of Candidates to be sent to Council by 1:30pm via mail.
- 4. Institute gate to be closed at 1:00 pm. **No candidate will be allowed** to participate at the 1st SPOT COUNSELING **after the reporting time.**
- 5. Institute will call out the students as per Merit list based on number of vacancies. Once the Vacancies are filled as per number of candidates present and eligible no further student's name will be called out.
- 6. All documents related to admission as per Annexure I to be verified by the institute for every candidate eligible for admission.
- 7. After admission, Institute to validate the admission of the candidate on the portal within the end of day on 19th October, 2022.
- 8. Counseling fee of Rs 500/- along admission fee, tution fee and other related charges of the Institution as applicable related to admission to be collected from each candidate.
- 9. Counseling fee collected from the candidates must be submitted to the Council after 2nd SPOT Counseling as per the directive issued by the Council.
- 10. Attendance list of the reporting candidates and the list of the admitted candidates must be sent to the Council after the completion of 1st SPOT Counseling on 19th October, 2022.
