

- 2. Mere submission of Google form shall not ensure/guarantee seat reservation. Candidates must **physically report** for taking admission.
- 3. Seats shall be allotted on "FIRST COME FIRST SERVE" basis.
- 4. Seat shall be allotted purely based on availability of seat vacancy **ON THE DAY OF REPORTING**.
- 5. Prior/Advance seat booking/reservation/assurance/confirmation/guarantee of seats <u>SHALL NOT BE</u> given to any candidate over telephone or any other means of verbal communication/ instruction/ request/recommendations.
