### (A) For 3<sup>rd</sup> Spot Counselling on 04/10/2024:

For admission in Polytechnics (both 1<sup>st</sup> year and 2<sup>nd</sup> year) for the academic session 2024-25, candidates are requested to fill-up their Choice of Institute (only one institute) in the portal <u>https://sctedved.wb.gov.in/polyadm/</u> by 03/10/2024 up to 05:00 p.m.

The candidates who have not applied earlier for admission in Polytechnics for the academic session 2024-25, are requested to sign up in the portal <u>https://sctedved.wb.gov.in/polyadm/</u> and fill-up details as it be given in the said portal.

# 2) <u>On 04/10/2024</u>, the candidates must remain present physically latest by 12:00 noon in the Institute for which choice has been given.

- 3) Candidates should bring with them the following documents on the date of spot counselling:
  - a) Application Acknowledgement Form for Spot Counselling;
  - b) All testimonials / documents (e.g. Admit Cards, Marksheets, Certificates, Caste Certificate, etc.) in ORIGINAL along with a set of photocopies of the same;
  - c) Two copies of recent passport size Photographs;
  - d) Domicile Certificate, Medical Fitness Certificate, Anti-Ragging Affidavit.
  - e) Admission of students should only be made on receipt of all fees related to admission of students under Spot Counselling through GRIPS portal as per directives of the Government.

### (B) For 4<sup>th</sup> Spot Counselling on 21/10/2024:

For admission in Polytechnics (both 1<sup>st</sup> year and 2<sup>nd</sup> year) for the academic session 2024-25, candidates are requested to fill-up their Choice of Institute (only one institute) in the portal <u>https://sctedved.wb.gov.in/polyadm/</u> by 19/10/2024 up to 05:00 p.m.

The candidates who have not applied earlier for admission in Polytechnics for the academic session 2024-25, are requested to sign up in the portal <u>https://sctedved.wb.gov.in/polyadm/</u> and fill-up details as it be given in the said portal.

# 2) <u>On 21/10/2024</u>, the candidates must remain present physically latest by 12:00 noon in the Institute for which choice has been given.
